Brief description of Schools:

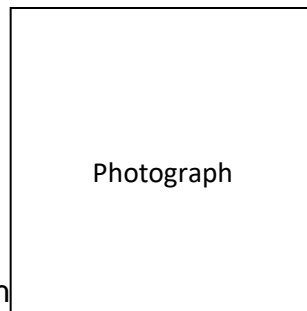
