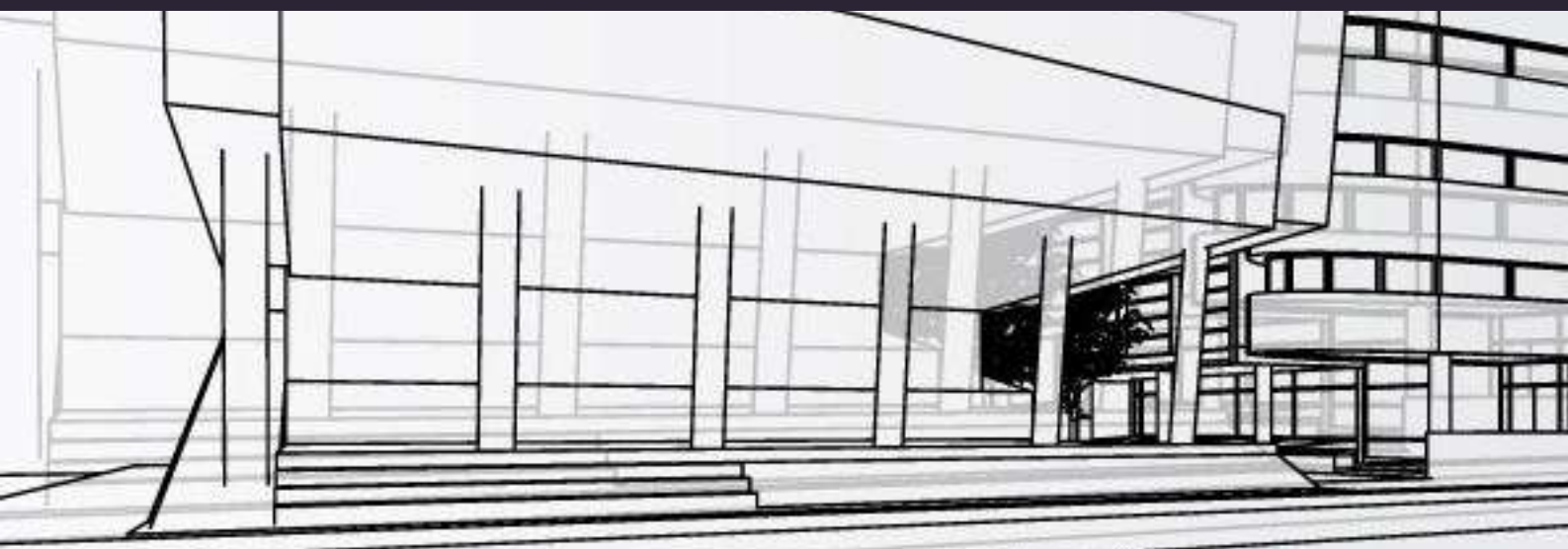

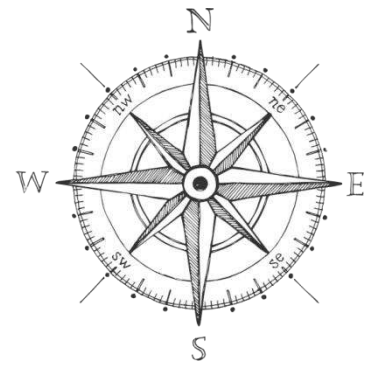

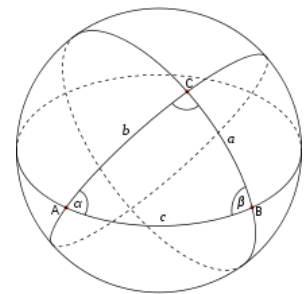
Program Overview
