Certificate Programme in CSR - Warm-Up Session for Batch-V

In order to enable companies to redefine Corporate Social Responsibility as an integral part of value creation purpose of the organisation, NFCSR is providing a 9-month online IICA Certificate Program (ICP) in CSR. The course is uniquely designed by balancing theory and practice focusing on the complete lifecycle of CSR. IICA Certificate Programme in CSR (ICP in CSR) which is a long-term course for developing trained and certified CSR professionals in the country has announced its Batch-V and a warm-up session was conducted on Sunday, 30th June 2019. The topic of the Master class for ICP - CSR Batch V was "Promoting Development through CSR as a new paradigm". It was a one and half an hour session which was joined by 30 students. The session was be taken by Prof. (Dr.) Shubhashis Gangopadhyay, an eminent economist who is currently serving as Secretary-General of India Development Foundation (IDF). He is the Founder and Research Director of IDF. He is also the Professor of Emerging Market Finance, University of Groningen, Netherlands and Visiting Professor, Gothenburg School of Business, Economics and Law, Gothenburg University, Sweden.

RESEARCH & PRACTICE

Need Assessment Report for Restoration of John Hall in Gurugram for IGT Solutions

The Indian Institute of Corporate Affairs conducted a need assessment study for the restoration of a cultural heritage site – John Hall in Gurugram, Haryana is also known as the Agricultural Hall. A team of conservation architects was involved in the study. The team worked on condition mapping of elevations, material extant drawings, and on existing roofing details, false ceiling section, wall panel detail, and flooring details. On the basis of the details, the team worked on the 3D model of the structure and proposed several recommendations. The team also worked on secondary research through archival sources of architectural colleges in Gurugram and Delhi and completed photo documentation – digitization and stitching of photographs for photo analysis, working on archival research too. The report submitted by the team was reviewed by the Archaeological Survey of India. The scope of further study related to structural and material testing before the commencement of the restoration process has been incorporated in the report.

Baseline Study and Impact Assessment Study for the CSR Projects Of Agriculture Insurance Company of India Limited (AICL)

Before initiating any new CSR project, an in-depth survey of the area helps to establish the baselines of relevant conditions and needs which should be undertaken in order to assess the future results of the project developed. The work has commenced for conducting a Baseline Survey as well as Impact Assessment Study for various CSR projects of AICL in multiple locations. Community development initiatives are a major component that AICL focuses on. AICL has adopted a multi-pronged approach and is trying to improve upon the standards of education and integrated rural development. The ultimate test of the success of any CSR project is its social, economic or environmental impact. In order to examine whether the CSR interventions of AICL were designed in line with the needs of the community and whether the projects made an impact on the lives of the beneficiaries, an impact assessment study is being conducted by reviewing the projects' achievements of project RISE: Remedial Innovation in School Education. This study is an effort directed towards understanding and assessing the impact of CSR interventions of AICL on the villagers of Delhi.

The Baseline Survey would simultaneously be conducted in order to identify ten disadvantaged villages of Delhi for further assessment of scope of work under Integrated Rural Development project areas.
