PROGRAMME FLOW

The two day workshop on “Familiarization Program for Independent & Women Directors” was inaugurated with the theme address of Dr. Niraj Gupta, Head SoCGPP, IICA.

Session 1: Dr. Ashish Makhija discussed the Corporate Governance concepts and regulatory updates.

Session 2: Mr. Milind Sarwate familiarizes directors about the how competencies can be build for enhancing the performance of Independent Directors at the board.

Session 3: Dr. Chris Pierce delivered his session on Board Effectiveness and the Role of Independent Directors

Session 4: Dr. Ashish Makhija discussed about various committees on boards and how Independent Directors can building safety net for them while discharging their duties on board.

Session 5: Mr. Shailesh Haribhakti shared his experience and delivered his session on How to Build Board future ready

Session 6: Mr. Nawshir Mirza explained the Role of Independent Directors in Audit Committee and shared few tools on how various frameworks can be developed

Session 7: CA Gyan C Pipara discussed and familiarized the IDs about the various nuances of financial statements.

Session 8: Mr. Robert Gordon oriented Participants about dynamics of Board Culture and Role of IDs in determining the effectiveness of the board in leading and directing the business and in its ability to achieve its full potential.
