**Five-Day Familiarization Capacity Building Programme
on
“Public Procurement (Policy and Procedures)”
*Endorsed by the Department of Expenditure, Government of India***

Dates: 19 - 23 January 2026

Venue: Hotel Grande Delmon, Goa

Organized by: Indian Institute of Corporate Affairs (IICA), Ministry of Corporate Affairs, Govt. of India

In the backdrop of India's expanding market size, strengthening manufacturing capabilities and the national aspiration of achieving *Viksit Bharat @2047*, public procurement assumes a critical role as a strategic instrument of governance, economic growth and industrial development. Recognizing the increasing complexity, regulatory evolution and strategic importance of procurement, the Indian Institute of Corporate Affairs (IICA), through its Centre for MSME, organized a **Five-Day Familiarization Capacity Building Programme on “Public Procurement (Policy and Procedures)”** from **19 to 23 January 2026** at Goa.

The programme was conducted under the aegis of the Ministry of Corporate Affairs and was formally **endorsed by the Department of Expenditure (DoE), Government of India**, reinforcing its relevance, credibility and alignment with national procurement reforms.

The programme was designed to:

- Strengthen conceptual clarity and practical understanding of public procurement policies, procedures and regulatory frameworks.
- Enhance institutional capacity for transparent, efficient and value-driven procurement of goods, works and services.
- Build competencies in procurement planning, tendering, bid evaluation, contract management and risk mitigation.
- Promote compliance with evolving Government of India procurement policies, including Make in India (MII), Public Procurement (Preference to Make in India) Order, MSE procurement policy and GeM guidelines.
- Enable participants to manage procurement as a strategic function contributing to efficiency, accountability and fiscal prudence.

The programme witnessed active and engaged participation from officers and professionals representing a diverse cross-section of **Central Government Ministries, Autonomous Bodies, Public Sector Undertakings (PSUs), Financial Institutions, Academic Institutions and Statutory Bodies**. The diversity of participants enabled rich peer learning, cross-sectoral perspectives, and constructive deliberations

The sessions comprehensively covered the end-to-end public procurement lifecycle with emphasis on both policy and practice. Key thematic areas included:

Special emphasis was placed on **risk management in public procurement**, understanding contracts as **risk allocation mechanisms** and ensuring value for money while maintaining transparency and accountability.

The programme adopted an interactive and practice-oriented pedagogy comprising:

- Expert-led classroom sessions
- Case studies and real-life procurement scenarios
- Structured presentations and guided discussions
- Question-and-answer sessions and peer interactions

Participants were provided with comprehensive reference materials and presentations to facilitate post-programme application and institutional learning.
