The following methods will be used for the purpose of data collection:

HH Survey/Key Informant Interviews/FGDs: Panchayats, School Officials, Beneficiary Groups etc.

Duration and Timeline

The field Investigators are expected to complete the data collection process within 10 days.



Quality assurance & Monitoring

The Project Managers/ Senior Research Associates/ Research Associates and other designated members from CfE2E (IICA) will supervise the field visits to ensure quality of data through back checks and spot checks. The study tools would be so constructed by CfE2E in such a way that there would be an internal check on erroneous data. Once selected, CfE2E will train the enumerators with respect to carrying out the data collection process.

Evaluation Criteria:

Proposals that do meet the eligibility criteria will be evaluated against capability and experience in providing services and availability of suitable manpower. This evaluation will be conducted with respect to the agency as a whole, and with respect to the team proposed.
