Sir,

Indian Institute of Corporate Affairs, Ministry of Corporate Affairs, Government of India "IICA", having its campus at Plot No. P-6-7-8, Sector 5, IMT Manesar, District – Guru gram, Haryana – 122052, intends to dispose of scrap material of mixed / miscellaneous type, located within its campus across various locations.

- 2. The scrap is to be disposed of by way of sale through bidding in one lot to the bidder quoting the highest "H1" per Kilogram rate in response to this RFP.
- 3. The approximated / estimated weight of this scrap would be 9-10 Tons approx., based on preliminary visual assessment. However, the actual weight may vary and may be higher or lower than the approximate/estimate.
- 4. The "Scrap" is to be sold off on "AS IS WHERE IS AND WHATEVER THERE IS" and the H1 bidder shall be required to have the scrap disposed by way of having the scrap removed and collected from the IICA Campus at its own expense and by its own arrangements.
- 5. The bidder shall repair/rectify/replace at his own cost any property belonging to the IICA, which is damaged in the act of removal of the material.
- 6. The base per kilogram price for the scrap shall be decided by the scrap disposal committee based on preliminary market survey from local scrap dealers at Manesar. In the preliminary market survey, five to six quotations from the local scrap dealers will be called for, to provide, the estimated weight as well as rate per kilogram of the mixed scrap in "INR /Kilogram". Thereafter, average of all these quotations will be calculated which shall be taken as the average weight and average base per kilogram price for the mixed scrap. Average weight multiplied by the average rate will be taken as the total base value of the mixed scrap

proposed for the sale. Any proposal received with quotes of values less than that shall be rejected.

- 7. The proposal(s) received in response to this RFP shall be evaluated by the scrap disposal committee, duly constituted by the Director General & CEO, IICA.
- 8. The "Award of Sale" for the net weighted scrap shall be made to the bidder quoting the highest "H1" per Kilogram rate in response to this RFP.
- 9. The "H1" bidder shall at its own expense make arrangements for weighing of the scrap on a pre-decided date in front of scrap disposal committee as well as IICA authorized officials and the final "Weight" weighed shall be attested by way of a joint document duly signed and ink stamped (at the same location and time) by the H1 bidder's authorized representative and IICA authorized official, post completion of the weighing process of the scrap. The final "Weight" so measured, shall be final and fixed and no changes shall be permissible, whatsoever. Final weight measured of value involving fractions of 500 grams and above shall be rounded off to the next higher kilogram value and involving fractions of less than 500 grams may be ignored. The entire process shall be photographed/video graphed, for record purpose by IICA.
- 10. The successful bidder will be liable for adherence to provisions of all relevant Labor laws, especially Minimum Wages Act, Workmen's' Compensation Act, etc. and shall indemnify the Department against any claims arising out of the same.
- 11. In case the services of a weigh bridge are to be used, if so decided and designated by mutual consent of the bidder and IICA, the empty vehicle shall be weighed in presence of a representative/representatives of the IICA. Once the vehicle is loaded, a representative/representatives of the IICA will again accompany the said vehicle to the weigh bridge site and the weight will be checked and certified by the bidder/ authorized representative of the bidder and representative(s) of the IICA.
- 12. In all matters relating to measurement, including weight of the material lifted and percentage of material removed, the decision of the IICA shall be final and binding.
- 13. The bidder shall repair/rectify/replace at his own cost any property belonging to the Department which is damaged in the act of removal of the material.
- 14. The final sale price for the entire "Miscellaneous scrap" lot shall be as given below:

## Sale Price: "H1" x "Weight"

- 15. Sale Price, so deduced, involving fractions of 50 paisa and above shall be rounded off to the next higher Rupee and involving fractions of less 50 paisa may be ignored.
- 16. The "HI" bidder shall, thereafter arrange to deposit the final "Sale Price" in the bank account of IICA, copy of the deposit transaction of which shall be submitted to IICA, Ministry of Corporate Affairs. Post confirmation of the receipt of the sale price by IICA, the H1 bidder shall be cleared for collection and pickup of the final weighed scrap.

- 17. The Department reserves the right to cancel the bid/ tender at any time without assigning any reason.
- 18. Accordingly, you are requested to submit your competitive bids for purchase of the "Mix Scrap" on per kilogram rate basis, on **AS IS WHERE IS AND WHATEVER THERE IS**" basis. #### B. Eligibility/Qualification Criteria

- i) The bidder should possess a registration as a firm under Proprietorship / Partnership or a firm, with any Government Authority. (Certificate issued by Shops and Establishment registration or Service Tax (GST) Registration or any other issuing Authority).
- ii) Agencies without having valid registration and authorization will not be allowed to participate in the bid.
- iii) All bidders must enclose GST registration certificate along with the tender documents.

#### C. Terms & Conditions for the Disposal of Scrap Items

- 1. The bid shall remain valid for 21 days after the date of bid opening. If any bidder withdrawshis/her tender before the said-period, he/she shall without prejudice to any other right or remedy, be at liberty to forfeit the Bid Security absolutely.
- 2. The scrap offered for disposal is on "AS-IS-WHERE-IS" basis, as Ex-Go-down in unpacked condition.
- 3. The Security Money Deposit (SMD) of Rs.10000 /- must accompany with each technical bid. This shall be in the form of Demand Draft drawn on ABCD Bank in favour of "Indian Institute of Corporate Affairs, without which the tender shall be summarily rejected. No Cheque / Money order / Cash shall be accepted. The tender fee and SMD deposit shall not attract any interest.
- 4. The bidders may inspect the items on predetermined dates and satisfy themselves about the items they are bidding for, as the items condition is on "As-Is-Where-Is 'basis.
- 5. The tenders should be submitted in sealed covers. Quotation/tenders not in sealed cover will be rejected. The bidsshould be hand delivered in front desk in IICA.

In case there is any error between the amount specified in figures and words, the higher of the two will be taken for consideration.
- 9. The items shall be sold to the **H1 bidder** i.e. the bidder that offers Highest Price.

- The SMD of unsuccessful bidders shall be returned within one month after opening thebid, without any interest.
- 11.
