

GROUP DISCOUNT SCHEME FOR ICMP

Greetings from the Indian Institute of Corporate Affairs, Ministry of Corporate Affairs, Government of India!

We, at Centre of Excellence in Alternative Dispute Resolution, are glad to invite registrations for the '**IICA Certified Mediator Program (ICMP)**' under our Group Discount Scheme which shall be as follows:

Participants sponsored by their employers or organizations shall be eligible **ONLY** for the following group discounts on the **Registration Fee i.e. INR 59,000/- (INR 50,000/- + 18% GST)**.

2-5 Participants: 10% discount

6-9 Participants: 15% discount

10 or more Participants: 20% discount

EXAMPLES OF COMPUTATION OF FEE UNDER GROUP DISCOUNT:

1. **SCENARIO 1 – Individual Registration:** Let's assume a candidate individually opts to register for the program, hence, no discount shall be applicable and **payable Registration Fee for such individual candidate** comes out to be **INR 59,000/- (INR 50,000/- + 18% GST)**.
2. **SCENARIO 2 – Sponsored Group Registration registering under the category “2-5 Participants”:** Let's assume two candidates are nominated from one organization (“Sponsoring Organization”). Hence, in accordance with the applicable 10% discount for the two candidates proposed to be sponsored by Sponsoring Organization, the **applicable Registration Fee per candidate** comes out to be **INR 53,100/- (INR 45,000/- + 18% GST)**.

Accordingly, the total **PAYABLE FEE** by Sponsoring Organization for two sponsored candidates comes out to be **INR 1,06,200/- (INR 53,100/- x 2 sponsored candidates)**.

3. **SCENARIO 3 – Sponsored Group Registration registering under the category “6-9 Participants”:** Let's assume six candidates are nominated from one organization (“Sponsoring Organization”). Hence, in accordance with the applicable 15% discount

for the six candidates proposed to be sponsored by Sponsoring Organization, the **applicable Registration Fee per candidate** comes out to be **INR 50,150/- (INR 42,500/- + 18% GST)**.

Accordingly, the total **PAYABLE FEE** by Sponsoring Organization for six sponsored candidates comes out to be **INR 3,00,900/- (INR 50,150/- x 6 sponsored candidates)**.

4. **SCENARIO 4 – Sponsored Group Registration registering under the category “10 or more Participants”**: Let’s assume ten candidates are nominated from one organization (“**Sponsoring Organization**”). Hence, in accordance with the applicable 20% discount for the ten candidates proposed to be sponsored by Sponsoring Organization, the **applicable Registration Fee per candidate** comes out to be **INR 47,200/- (INR 40,000/- + 18% GST)**.

Accordingly, the total **PAYABLE FEE** by Sponsoring Organization for ten sponsored candidates comes out to be **INR 4,72,000/- (INR 47,200/- x 10 sponsored candidates)**.

REGISTRATION PROCESS:

To proceed with registration for the proposed number of sponsored participants, Sponsoring Organization shall make a direct bank transfer of the **PAYABLE FEE** to the IICA’s Bank Account, details of which are provided in the cheque annexed herewith on the last page. Once the bank transfer has been made, kindly reply to this email with the payment confirmation receipt along with the list of sponsored participants with the following details for each participant:
